This is with reference to the above proposal. The Conservator of Forests, East Circle, Jammu/DFO Kathua/ User Agency are requested upload the following documents, within two days:-

- 1. Form-A K(i)- it has been mentioned that FRA has been completed as "YES", however, copy of documentary evidence in support of settlement of rights under the Forest Rights Act, 2006 on the forest land proposed to be diverted under column K (a) has not been uploaded. ---Action by User Agency.
- Village Wise break under column B-2.3 need to be given by the user agency -Action by User
- In Part-II, under column 5, the working plan prescription of the forest area involved need to be given by DFO Kathua. --- Action by DFO Kathua.
- 4. The CA Plan on degraded forest land double in extent of forest land has been prepared and uploaded. However, Chapter 2.5 (Page No. 47 of the Handbook) indicates that CA shall be raised and maintained over an equivalent area proposed for diversion in a degraded forest in RFs or such other forest land which are already under administrative control of the SFD at the cost of the user ageny in case of strategic Defence projects including infra-strucutre and road projects undertaken by the BRO. ---Action by DFO Kathua.
- Under column 8(i) DFO Kathua has reported Barking Deer, Indian Fox, Jackal, Leopard, Jangle Cat, Pehesus Macaque, Common Gecko, Common Garden Lizard in and around the proposed forest area for diversion. The comments of the J&K Wildlife Protection Department need to be obtained and uploaded. --- Action by DFO Kathua.
- The proposed diversion is for widening of the existing road. The status of existing road passing through forest area need to be given. In case, the forest area falling under the existing road has been diverted under the provisions of Forest Conservation Act, a copy of the sanction order need to be uploaded. In case the existing road passing through forest area constructed prior to 1980, a certificate need to be uploaded by the user agency.--- Action by User Agency/DFO Kathua
