In the Ref (2) cited above, the Block Development Officer (BP), Nallampalli block, Nallampalli, Dharmapuri District, has submitted proposal under Sec (2) of Forest (Conservation) Act 1980, for diversion of 2.50 ha of Forest land for formation of road from Barigam Konayankadu to Malayurkadu in Dharmapuri Forest Division area.

In this regard, the proposed diverted land and Compensatory Afforestation land was inspected by me on 12-08-2020. As per para 3.2(i) of the Guidelines issued under the Forest (Conservation) Act, 1980, Compensatory Afforestation must be done over equivalent area of non-forest land subject to the following:

As far as possible, the proposed Compensatory Afforestation land has to a) be contiguous to existing Reserve Forests, Reserve Lands or Recorded Forest areas, to enable the Forest Department to effectively manage the newly planted area.

- b) The proposed Compensatory Afforestation land shall be suitable for raising successful plantation.
- c) The land parcels identified for Compensatory Afforestation shall be mutated in land records in the name of Forest Department, thereafter, to be notified as Reserve Forests
- d) The identified land parcels shall be compact i.e. without any pockets of habitation or non-forest land
- e) The land identified for Compensatory Afforestation shall be free from any encumbrances.

But in the above proposal, the area identified in Nekunthi Village for Compensatory Afforestation is not fulfilling above conditions. The area is not suitable for raising successful plantation and it is not contiguous to existing forest areas. However, suitable land is available in the same Survey no, i.e., adjacent to S. F. No. No. 320 of Nekkundhi village. This land parcel (S. F. No. 320) has already been notified as Reserve Land under Sec (4) of Tamil Nadu Forest Act, 1980 in Govt. Order (Ms). No 888, Environment and Forests Department, dated 21-08-1986.

In addition to the said proposal, this office received 3 more proposals from Rural Development and Panchayat Raj Department, for diversion of forest land for Road formation. The total requirement of CA Land for all pending proposals will be is 39.00 ha.
