I am directed to refer to the State Government of Uttarakhand's letter No.381/FP/UK/MIN/38285/2019 dated 07th August, 2020 on the above mentioned subject and to inform that the submitted revised KML file of Compensatory Afforestation (CA) site has been analysed on DSS and found some discrepancy which may needs to clarify before further action in this proposal:

- i. The total calculated CA area from the KML files is found 1095.64 ha whereas the actual CA area proposed is 1325.00 ha.
- ii. Out of total area proposed for CA, 71 ha of land is classified as Very Dense Forest (VDF) and about 298 ha of land is classified as Moderately Dense Forest (MDF), which need to be changed. The details of these site are as below:
