Sir,

With reference to the subject and letter cited above, I am directed to inform that three numbers of proposals for Forest Clearance under Forest (Conservation) Act, 1980, have been received in Regional Office, Shillong vide State Govt of Assam letters under reference above. The submitted three (3) Nos. of proposals have been examined in this office and found that the proposals submitted under reference (i) & (ii) above are located in the close proximity near the Kulshi river bed. In this regard it may be mentioned that there are Civil Writs petition filed in the Hon'ble High Court of Gauwahati related to proposals of sand Mahals/Mining in Kulsi River which are still subjudiced. Moreover, the mining zone is to be identified and State Govt of Assam is to follow the Supreme Court Order dated 27.02.2012 in case of Deepak Kumar Vs State of Haryana before submitting any mining proposal for forest clearance under Forest(Conservation) Act, 1980 as per the Ministry's letter No. File No. 8-6/2017-ROHQ dated 02/05.02.2018 addressed to you.

In view of the above the following proposals i.e

- 1) Diversion of 1.0 ha of forest land for operation of Bherbheri Sand Mahal No. 2 in Kulshi and Pantan RF under Kamrup West Division Bamunigaon in favour of Sri Dipak Rabha.
- 2) Diversion of 1.0 ha of forest land for operation of Hatigarh Sand Mahal No. 2 in Kulshi and Pantan RF under Kamrup West Division Bamunigaon in favour of Sri Dipak Rabha.
- 3) Diversion of 1.0 ha of forest land for operation of Ekchelia Sand Mahal No. 2 in Milmilia RF under Kamrup West Division, Bamunigaon in favour of Sri Dulal Kalita

are hereby returned in original and State Govt is requested to take necessary action as per the Ministry letter No. File No. 8-6/2017-ROHQ dated 02/05.02.2018 and Regional Office, MoEF&CC, Shillong letter No. RONE/MISC/AS/2014-SHI 3041-43 dated 24.01.2018 (copies enclosed) and resubmit the proposals.
