- i. The activity is permitted in the Rule- 5(2)(h), Voluntary relocation of villages from protected areas (CAF Rules 2018).
- ii. The proposal considering that the relocation of villages from Kaziranga National Park will immensely benefit wildlife habitat and ecosystem of the Protected Area by significantly enhancing ecological services and reducing man-animal conflicts.

- iii. The relocation process should be voluntary and strictly as per guidelines of National Tiger Conservation Authority (NTCA) and the policies of the State Government. Further it should ensure that the relocation is permanent and complete. The relocated families should be brought to the mainstream of development process. The State Government should confirm the completion of the work of village relocation of the people from the protected area.
- iv. The approved activities shall be carried out as per Rule- 4 of the Compensatory Afforestation Fund (CAF) Rules, 2018 i.e. as per the provisions of the State Financial Rules or any such rules applicable from time to time in the State.
- v. Utilization of State Compensatory Afforestation Fund (CAF) shall be done in such a manner that at least 80% is used for afforestation, forest development and wildlife habitat improvement and up to a maximum 20% amount is to be used for infrastructure/capacity building related items.
- vi. IRO should inspect the area and give a report before & after relocation.
- vii. The validity of APO (2022-23) shall expire on 31.03.2023. Further continuation of the incomplete activities shall be permissible only if they are included in the APO (2023-24) and are approved.
