Sub: Guidelines under the Forest (Conservation) Act, 1980- Clarification on drilling of shot holes for seismic surveys- reg.

Sir,

In continuation of this Ministry's letter dated 03.03.2016, I am directed to say that para 1.3 of guidelines issued under the Forest (Conservation) Act, 1980 inter-alia provides that investigations and surveys carried out in connection with development projects such as transmission lines, hydro-electric projects, seismic surveys, exploration for oil drilling, mining etc. will not attract the provisions of the Act as long as these surveys do not involve any clearing of forest, and operations are restricted to cleaning of bushes and lopping of trees branches for purpose of sighting. This Ministry has received representations, wherein this Ministry has been requested to clarify the number of shot holes to be drilled for seismic survey, which will not attract the provisions of the Forest (Conservation) Act, 1980.

After careful examination of the matter in this Ministry, I am further directed to say that the seismic surveys for oil and gas exploration which require use of small explosive material specific to seismic survey for purpose of energy generation in shot holes in forest land will not attracts the provisions of Forest (Conservation) Act Provided that these surveys do not involve any clearing of forest, and operation are restricted to cleaning of bushes and lopping of trees branches for purpose of sighting and the density of shot hole for such seismic survey is restricted up to 16 boreholes of maximum 6.6" diameter per 10 sq km.
