The undersigned is directed to enclose herewith State/UT wise detail of inspection reports pending with various Regional Offices of the Ministry and to inform that progress of implementation of time lines by the Regional Offices in accordance with the provisions of Van (Sanrakshan Evam Samvardhan) Rules, 2023 was reviewed by the Ministry on 19.11.2024, wherein, it was observed that many inspections reports are pending beyond the stipulated period as prescribed in the Van (Sanrakshan Evam Samvardhan) Rules, 2023. Currently, total 76 inspections reports are pending with the Regional Offices out of which 65 are pending for a period of more than one month (Status report enclosed). The Competent authority of the Ministry viewed the matter very seriously and recorded displeasure over delay in submission of inspection reports by the Regional Offices. It has been desired that all Regional Offices of the Ministry should adhere to the timelines prescribed in the rules failing which stern actions will be taken by the Ministry against the concerned officers of the Regional Office.

It is also informed that refined module for submission of site inspection reports has been made live on 28.08.2024. Regional Offices are, therefore, requested not to upload the site inspection report as additional documents or attachment in the notesheet and to ensure that inspection reports with clear recommendation of the DDG are furnished through designated module integrated in PARIVESH 2.0.

In view of the above, all Regional Offices are hereby directed to adhere to the timelines provided in the Rules in conduction and submission of their site inspection report and also to furnish the pending reports, through designated module, to the Ministry without any further delay.
